Opinion

We have audited the accompanying financial statements of Kenya Kesho, set out on pages 5 to 7 which comprise the statement of financial position as at 30th September, 2018 and the statements of comprehensive income, statement of changes in equity and of cashflows statement for the year then ended, and, notes, including a summary of significant accounting policies.

In our opinion the accompanying financial statements give a true and fair view of the financial position of the trust as at 30th September, 2018 and of its financial performance and cash flows for the year then ended in accordance with the International Financial Reporting Standards for Small and Medium-sized Entities and the requirements of the Kenyan Companies Act 2015.

Basis for opinion

1. BASIS OF ACCOUNTING
